- 4.23 OPEN SESSION Matters raised by the public: Cllr Daunt raised the matter of the mole hill near the play area this was raised at the last meeting and it was agreed to monitor this situation as there had been no new hills.

  - c) The Clerk advised there had been some problems on the school road whereby glass had been smash and a young child injured. The road is now monitored by CCTV and the offenders have not returned since the incident.
