**140.22 MINUTES –** The minutes of the February meeting were confirmed as a true and accurate record

Prior to the Open Session a presentation was made to Cllr Bingham on the occasion of his retirement. The Chair thanked him for all his past help and long service to the community. Cllr Bingham thanked the Chair and Council for their kind words and gave a brief history of his service.

## **141.22 OPEN SESSION –**Matters raised by the public:

A member of the public wanted to raise the matter of the lack of railing outside the Club Inn to protect people from the traffic especially at night. It was pointed out the railings were removed by Highways some time ago. The council was advised an elderly lady had fallen coming out of the Club Inn recently and had to lay in the road until an ambulance arrived, it was thought that had there been railing these would have stopped falling into the road. A further matter raised was the name advice sign at the junction of Woodside Road leading to Long Close and other areas which is very faded. The Parish Clerk and the Unitary Councillor, Cllr Battye will contact Highways to see if they will reinstate the railings as a safety measure and replace the name road sign.

142.22 The Secretary of Endmoor Tennis Club attended the meeting to advise the council of the details of their request for CIL money to upgrade the infrastructure of the tennis courts. He explained they wished to attract more members by improving the facilities. The Club had obtained two like for like quotes which were discussed, these proved to approximately the same costs. Cllr Mason proposed we offer £5,000 and Cllr Park seconded all agree.

The Clerk advised she is still trying to sort out a noticeboard for the Fellside Manor area, she has established we will not require planning permission however we do need permission from the land owners where we wish to site

#### 144.22 DISTRICT/COUNTY COUNCIL MATTERS -

Cllr Battye being our Unitary Councillor gave the following report.

She advised the transfer would be seamless as the number of staff have increased from 3 to 3,600 and everything would be in place to keep us safe and legal. By bringing the County and District together as the Westmorland & Furness Council it will make things better. Local area boards will be put in place to liaise with areas to make things more local. A councillor wanted to know about the introduction of the need for ID verification when voting in elections, Cllr Battye advised this was a government directive and the council was complying with their instructions. The question was asked what if you do not have ID such as passport, driving licence what is acceptable? Cllr Battye will make enquires and advise at the next meeting.

- 145.22 HIGHWAYS Discussion took place regarding the numerous potholes and issues with signs and lights around the parish. The Clerk noted them all to report to Highways however she pointed out although the report is from the Parish Council this is only regarded as one report and doesn't indicate the serious of the problem.
