CIL money has been used to provide new bus shelters at Crooklands, new street lights on Low Park, new noticeboards around the parish, new play equipment for the Play area, update to the tennis courts, new bench for the Jubilee, new CCTV to oversee the 015395 67411

village hall, play area, tennis courts and playing field and last but not least electricity to light up our Christmas Tree. My thanks to my fellow councillors for their support and assistance.

The Broadband team have been working hard implementing B4RN hyper fast broadband into much of the parish which has been hard work, J. Lyons has overseen the project, Glenn Smithers has look into wayleaves and done much admin, other volunteers have dug trenches, overseen website and negotiated with B4RN and the Parish Council has looked after the finances so our thanks to all those involved in the project which is now drawing to a close. A plaque has been placed on the Millennium Clock in recognition of their achievement.

Roger Gorman had once again looked after our Preston Richard Emergency Plan (PREP) and kept us all informed as necessary. I would like to thank our PREP team and volunteers for the wonderful work they have done in supporting everyone and in particular Roger Gorman who works tirelessly in ensuring we are kept up to date.

Other thanks should go to Julia Smithers for organising the Christmas Carol Service around the clock and the team who installed and decorated the tree, to Sam Clarke and volunteers for organising the Jubilee Celebrations.
