82.23 OPEN SESSION -

Resident raised several issues

- Concerns were once again raised regarding the closed footpath adjacent to the Story Homes development, the clerk advised we had made numerous attempts to get it reopened without success however the temporary closure order expires on 1st March 2024 and if no further closure order is applied for it will reopen then. A resident also noted that the footpath had been moved and the Chair advised that was in the plans which were passed by the planning authority. The Clerk will send details to the resident.
- A member of the public had previously asked if more Parish Councillors should be appointed in view of the new development. The Clerk advised she had made enquiries and the electoral department would look into this if requested by the Parish.
- A resident asked if the pavement from Gatebeck Road down to Gatebeck Lane bridge could be cleared of leaves and debris. The Clerk has reported this to Highways for their attention.
- 83.23 CHRISTMAS GATHERING AT THE MILLENNIUM CLOCK All the accounts are now in for payment; the Parish Council approved them for payment. It was noted the estimate for the carol books was higher than expected but this was due to them being laminated to enable them to last

POLICE —Police information can be found on their website Home | Cumbria Police or on their Facebook page South lakes police - search results | Facebook. The most prominent news was the success of operation Merlin which resulted in 20 arrests throughout Cumbria for drug offences. The Clerk advised the Police were introducing a new 'Streetsafe' initiative whereby members of the public can report safety concerns in public places anonymously, on line. This includes things such as poorly lit streets, abandoned buildings, vandalism, verbal abuse in the street, broken glass in or dangerous items in public places. 85.23 UNITARY COUNCIL MATTERS -

- Clir Battye advised that Westmorland & Furness Council (W&F) have set out their budget increase for 2024-25 and are asking people to go on line and give their opinions, go to <u>Budget consultation 2024 to 2025</u> | <u>Westmorland and Furness Council</u> for more details.
- She advised the signs for dog fouling notices around the Dove Nest Lane area are ready and will be put up shortly. The Chair asked if there will be any enforcement, Cllr Battye said she would check up on this when the signs are installed.
- We have a new Chair for Endmoor Village Hall and she will advise the Parish Council of the Chairman's name by email.
- She has found a contact for the Speedwatch management within the Police; however, this is Sgt. Scott-O'Neill with whom the Parish Council have dealt with for many years on this matter. Cllr Battye will ask Sgt Scott-O'Neill if she will attend a Parish Council meeting to discuss all aspects of speeding in the Parish. Cllrs asked when are we going to get some speed cameras in the village on the A65 as it is a major road and need some slowing down measures put in place. Cllr Battye mentioned the new voluntary 20mph initiative, the council felt that it may be fine on housing estates but does not work on major A routes. All matters related to speeding will be put on the January agenda for discussion.
- 86.23 NOTICEBOARD FOR FELLSIDE MANOR -The Noticeboard has now arrived however Story Homes will not allow it to be installed at the front of the development and want it put at the back where very few people will see it. As the Parish Council has permission to put it along the A65 verge we will look to installing it in an appropriate position on the A65 verge. The matter of the missing Endmoor sign on entering the north side of the village was raised, the clerk will make enquiries

89.23 FINANCE –

The Budget for 2024-2025 was discussed at length as many costs have risen and new charges have been applied by Westmorland & Furness Council. It was thought an increase of £1.5K on the budget would need to be applied, taking the budget to £30K less the unitary grant of £623.76 therefore £29,376.24 shared between all properties in the parish. The increases are due to increased street lighting costs up (63%), waste disposal costs, the charge to households should be somewhat offset by the
