# MINUTES OF THE MEETING OF PRESTON RICHARD PARISH COUNCIL HELD IN ENDMOOR VILLAGE HALL ON MONDAY 21st NOVEMBER 2022

- **92.22 KATH DOS SANTOS OFFICE OF ACCEPTANCE –** Cllr Dos Santos signed the acceptance form and was welcomed by all members of the Parish Council
- 93.22 REQUESTS FOR DISPENSATION None
- **94.22 DECLARATIONS OF INTEREST –** Cllr Atkinson declared an interest in item 102:22 Crooklands Hotel Planning application
- **95.22 MINUTES –** The minutes of the October meeting were confirmed as true and accurate records
- **96.22 OPEN SESSION –** No matters were raised by the public.
- 97.22 POLICE Cllr Bingham stated he had received complaints about ex criminals knocking on householder's doors and being quite aggressive. The matter of the increase in burglaries taking place in South Lakeland villages was also brought up, full information and advice has been put on the local Facebook Pages Endmoor & District Parish Council and Endmoor, Preston Patrick & Richard. Any suspicious behaviour should be reported to the police on 101. ### 98.22 DISTRICT/COUNTY COUNCIL MATTERS -

Cllr Bingham reported that a £600,000 government grant is available to restore the canal tow paths, however despite the excellent work by volunteers it is unlikely the four blockages caused by the M6 will ever be removed. Child poverty remain a concern for both SLDC and CCC. CCC have created a £4m Cost of Living Crisis fund. The cost of school dinners now £2.41 is likely to reach £3 although food inflation has dropped from its peak in July. Many schools now have breakfast clubs and food vouchers or meals provided during school holidays. On road safety matters the new 20mph limit for Gatebeck is appreciated, however further speed orders may have to wait until the outcome of the inquests held on the four fatalities within the Lower Kentdale Division. At last, in Endmoor, Dove Nest Lane and Enyeats Road are being resurfaced although her had been advised access problems had arisen today and he has

spoken with the engineers who will be on site tomorrow to rectify the problems and they will ensure this will not occur in the future. He has also received complaints that many officers are too distracted by the Local Government Reorganisation to attend to current enquiries promptly.

Cllr Battye advised that the matter of election expenses is being looked into and the new Unitary Council may pay future expenses. Some senior staff have been appointed within the Unitary Council and other staff members have been advised where they will be moved to. She explained the new Unitary Council is keen to work more closely with the Parish Council/Town Councils and has sent out questionnaires to get a better understanding.

She had also looked into the matter of complaints received about the parking problem when the cycling events were held in the Village Hall and explained that all events should be covered by public liability insurance and a Temporary Event Licence. The Clerk advised where the events encroached on to road there are other steps necessary such as advising residents in advance, risk assessments, the organisers contact details and public liability insurance should be taken out by the event organisers. The matter is ongoing.

**99.22 HIGHWAYS** – The Clerk was asked to report two matters. The Pothole at the bottom of the school road, Endmoor and the flooding a Rowell Bridge at Milton.

#### 100.22 PLAYING FIELD/VILLAGE HALL -

- As we could not find a suitable place to plant a tree at the village Hall area a memorial bench has been ordered to put by the clock.
- The new external CCTV system is currently being installed at the Village Hall.
- Work will commence on the Village Hall Garden next week and the new gardener will take over the village boxes and around the Millennium Clock.
- The matter of the Village entrance was discussed and the Chair asked for ideas, suggesting perhaps something to commemorate our gun powder heritage along the lines of Cllr Galbraith's suggestion last month. This will be discussed on the next agenda.

#### 101.22 CIL MONEY -

Expenditure this week

- Electricity supply to the Clock and Christmas tree has been carried out after finding a cheaper way to achieve this.
- It was decided by the Bowling Green Committee that they would repair the hut but they asked for a new noticeboard. Cllr Mason proposed we should purchase this Cllr Inman seconded all agreed.
- The Clerk pointed out two more lights on Low Park would need replacing during the next two years and it would be prudent to put money aside for this. Cllr Galbraith felt as we had the money and some had already been done to get them done now at the lower price, Cllr Atkinson seconded and all agreed.
