## 109.22 DISTRICT/COUNTY COUNCIL MATTERS -

No report was received from Cllr Bingham. Cllr Battye advised that the shadow authority of Westmorland and Furness Council had met that afternoon and agreed their vision and priorities for the future when they take over in April next year. The Clerk advised she had received an email on this matter late this afternoon and would forward it to the Councillors. Cllr Battye advised Jonathan Brook has been appointed the new leader of the shadow authority and that 88% of the current staff know where they will be when the new authority takes over.

**110.22 HIGHWAYS** – The Clerk was asked to report two matters. The drains on Gatebeck Lane which have sunk and cause problems as it is a narrow road and a pothole outside Gatebeck Holiday Park Gatebeck Road. The Clerk advised there had been problems during the cold spell on the School Road and Village Hall Car Park. She advised she had asked for the grit bins to be filled and a group of parents whose children attended the school are willing to spread grit using our manual push grit machine should the need arise. The Council felt one of the problems would be there would be insufficient salt in the one grit bin at

the Village Hall and Cllr Mason proposed a grit bin should be purchased to install on the school road, Cllr Galbraith seconded and all agreed. The Clerk will make enquiries regarding this matter. Councillors will also make enquiries regarding checking if there are any businesses that offer a gritting service.

## 111.22 PLAYING FIELD/VILLAGE HALL -

- The Jubilee seat has been delivered and will be installed in January
- The new external CCTV system has been installed at the Village Hall, there are a few minor changes required but it is working well. Discussions took place on the matter of a large van being parked on the car park which is obscuring the camera, this will be looked in to.
- The Village Hall Gardens are now tidy and ready for planting out in the spring.
- The Chair also remarked a barrier on the car park to keep vehicles off the garden had been hit and needs putting back, the councillors will get a tractor to pull it back and will be recemented if necessary.
- Many villages and towns now have something denoting their heritage as an entrance, ours it seems is built around the gun powder heritage and the council felt it would be good idea to open it up the residents to see what designs anyone could come up with. The Clerk was asked to pose the question on our website and Facebook page to see if any budding designers could help.
